#### Request for an opinion from the EESC (June 2023)

European Economic and Social Committee (EESC)

A European advisory council composed of employers, trade unionists and representatives of social, occupational, economic and cultural organizations

""We would appreciate an opinion on the steps the EU should take to establish a comprehensive just transition policy framework.

This framework should be capable of fostering a carbon-neutral, environmentally sustainable, non-toxic, and fully circular society and economy by 2050, without further jeopardising the socio-economic opportunities of vulnerable regions and people."



## EESC Opinion (14 December 2023) 'Advancing the EU's just transition policy framework: what measures are necessary?'

- A holistic, coordinated and integrated policy approach is at the heart of the JTPF --> insuring institutional anchoring
- The JTPF enables a sustainable economy that provides well-being for all within planetary boundaries --> Green Deal 2.0, and investments for transition
- The European Social Model and Member States' welfare systems are the backbone of the JTPF --> linking with matters at EPSCO
- Social dialogue, civic dialogue and the participation of local and regional authorities are the cornerstone to realise the JTPF --> multi-dialogues & territorial approach

- Strong and resilient sustainable businesses are a prerequisite for the functioning of the JTPF --> legal certainty of transition, and support of SMEs.
- Adequate investment in a just transition is fundamental to the realisation of the JTPF --> follow the money: policy coherence for transition
