Klimaat

COP26 in Glasgow (31 Oct.-12 Nov. 2021)

(voorafgegaan door Leaders Summit met aanwezigheid premier De Croo)

4 werkstromen

- *Enhancing national ambition in National Determined Contributions and Long Term Strategies*
- *Finalising the rulebook: missing parts are Art 6 Paris Agreement (markets), Common Timeframes and report formats of enhanced transparency system*
- *Upcoming mandates: new Climate Finance goal by 2025 and also strong insistence by vulnerable countries to make the adaptation goal more operational and measurable*
- *UK launched 5 Climate campaigns: energy transition; transport; nature based solutions; climate resilience and adaptation; sustainable finance*
- *-> coalitions of the willing to spur transition and gain political momentum*

COP 15 Biodiversiteit (Kunming 11- 24 oktober 2021 - tbc)

Dient Post 2020 Global Biodiversity Framework vast te leggen

- Link Biodiversiteit – Klimaat : nature based solutions – ecosystemen als bossen of veengebieden zorgen voor opslag broeikasgassen
- Belang integratie biodiversiteit in andere sectoren (landbouw, gezondheid,...)
- Aanscherpen van doelstelling rond beschermd gebieden zowel op het land als voor de oceanen
- Resource Mobilisation

- *"This meeting will be a milestone for reviewing and accelerating progress towards achieving SDG target 6.5 (integrated water resources management), discussing challenges and good practices related to transboundary water cooperation and the role of the Convention."*
- *Discussions on topics as*
 - *Equitable and sustainable water allocation*
 - *Water- food-energy -ecosystems nexus*
 - *Climate change adaptation*
- High level segment rond "Water and Peace".

Marine Milieu

1. **Ministerial Conference on Marine Litter and Plastics (1-2 September)**
2. **Ministerial Meeting OSPAR Convention for the Protection of the Marine Environment of the North-East Atlantic (Cascais, Portugal, 1 oktober)**
 - “*launch of a new North-East Altantic Environment Strategy 2030 to achieve a clean, healthy and biologically diverse North-East Atlantic, used sustainably*”.
 - Discussion on :
 - *The impacts of climate change (and ocean acidification)*
 - *Biodiversity loss and marine plastic pollution*
 - *The role OSPAR should play on the global stage, including its role in global negotiations on the conservation and sustainable use of marine biodiversity in areas beyond national jurisdiction.*
3. **Commission on the Conservation of Antarctic Living Marine Ressources – CCAMLR (online eind oktober - begin November – tbc)**
 - *Belangrijkste inzet is de goedkeuring van 2 nieuwe beschermde marine gebieden*

2. **COP Minamata** Kwik (online 30 oktober – 5 november)
